# II. Community Reports

- 1. <u>Cesar Ruiz</u>, Council District 8 Field Deputy
  Not in attendance. Mrs. Byrd stated that we are to be informed when a representative from Councilman Bernard Parks's office is not going to be in attendance to give us a report. A stakeholder gave a report on the clean-up that took place near Van Ness off Manchester and also near 75<sup>th</sup> Street and Van Ness. Not many people participated, however a good job was done, and refreshments were served that were sponsored by ECSWANC.
- 2. <u>Tim Wunderlich</u>, Senior Lead Officer 77<sup>th</sup> Division gave an update on crime in the area. Gave a report Notice of felons training youth to go door-to-door knocking on doors.
- 3. Officer Durant passed out listings of crime reports in her area on June 3-9, June 10-16 28 crimes, 1<sup>st</sup> week, 17 crimes 2<sup>nd</sup> week. Also noted that the serial rapist was captured, he had no rap sheet, never been arrested. Officer Durant passed out business cards and asks the stakeholders to continue to call when they see any illegal acts. She thanked the community for staying involved. A monthly report on crime stated for our council area.

- 6. Discussion on Marijuana Dispensaries The law was given in the state of California for medical use.

- 7. The ordinance is too broad, and because of this the law limits law enforcement on what they can and what they cannot do in relations to policing these labs. Discussion of a new location is at Manchester & Gramercy Place was discussed. Officer Durant described their restrictions based on the law. There are 100 certified listings, a list will be provided at the next meeting.
- 8. In August it is a possibility that Detective Derjo could attend our meeting and give an explanation of the laws that protect these labs.
- 9. Crime preventive measures that were discussed. Suggestions, perhaps neighbors could place security decals in their windows.
- 10.Mrs. Cotton is going to request the Public Works department to attend one of our meetings.

- 1. Karen Lane spoke on the Community Care Ordinance a new law is under review by the Los Angeles City Council to change the present law. She believes this is a violation. The ordinance will become law, proposed by City Councilman Englander, stating that residence of his are requested that he draft an ordinance stating homeowners cannot rent rooms within their residences. Support is needed to not allow this ordinance to be passed.
- 2. Joy Enix Spoke on the Community Coalition and the agenda, they are having an event on August 18<sup>th</sup> and would like ECSWANDA to consider having a table and also the opportunity to participate in their event.
- 3. Hazel Dean Spoke on the Homeowners agreement for maintaining grass behind their garages, especially near the coroner of Van Ness off of Manchester.
