### **South LA Strong**

Summer initiative to bring robust resources. Saint Andrew Park; Monday – Thursday: Yoga, Dance, Art, and Soccer offered to Youth. Movies in the Park 7 pm. The movie was done July 16<sup>th</sup> returning with the second July 30<sup>th</sup>. Register to have your own social distance Pod. Two new pools opened. Algin Sutton – 88<sup>th</sup> Hoover, and Van Ness Park – Slauson and Van Ness

**Illegal dispensaries** – Steps being taken to enforce the motion to padlock illegal dispensaries (Cannabis Enforcement Task Force). Working with LAPD, Building and Safety, . . . Who will keep the keys. The program will launch at the end of July/the beginning of August. Focus on Western Avenue between Manchester and Florence Avenue.

**Homelessness** – legislation – clean up and enforcement to resume. Second vote required and will occur after recess. Isaias will share the Council file in case public comment. If we can verify that you have a place for the homeless to move to and that you offer this place to them the legislation can be enforced. If we can clearly and quantitatively confirm that we have offered people services (houses that they can move into). Encampments cannot block access to driveways, schools, parks, and Freeways. We can serve the homeless once the legislation passes. CF#20-1376. The Board is welcome to bring public comment when the motion is brought back to council.

**Clean Up** - Three outside crews contacted to clean up community Coalition for Responsible Community Development (CRCD) and Los Angeles Conservation Corp (LACC) and Gang Alternative Program (GAP). Different parts of the district are being targeted daily. All crews will be active by August 1, 2021

**ARCO** withdrew application to sell liquor on Manchester and Wilton after receiving feedback from the community and the council that people are in opposition.

Job Fair – SOFI stadium held July 16, 2021. 200 offers made. Part time and Full time (Hospitality and Security). The SOFI event was held at the Baldwin Hills Crenshaw Plaza.

#### **Questions to Isaias Benavides**

- Chelsea: Will you have monthly meetings with updates? Task Force Cannabis Enforcement – monthly updates available at monthly ECSWANDC
- 2. Joy Can an update be made to all 15 Neighborhood Councils at South Los Angeles Alliance of Neighborhood Councils (SLAANC) meetings? We are there on a quarterly basis. We can present at SLAANC meetings, and we can attend more SLAANC meetings if the Vice-Chair requests.
- 3. Marcello Housing for the Homeless on Vermont Center medians. As the pandemic winding down it is easier move people, open shelters and use motel accommodations. We had to create more options and make offers. Outreach services were done first. We put more teeth in enforcement. The new motion allows enforcement to move people if we have a place to move them. Over the last year we invested in outreach services and alternative housing. Relationships with homeless exists. There are rules of where homeless encampments can be placed. HOPICs (Homeless Outreach Program Integrated Care System) LASA (Los Angeles Homeless Service Authority)
- 4. Elice what is the teeth in the legislation? The ability to offer housing and the authority to remove people once they have been offered housing. The teeth come with the ability to do enforcement. With the update to the motion, we can enforce and ask people to move if we have a place to offer them. We've had a CD8 relationship with the homeless for the last year. There is language (rules) that tell people where they are not allowed to locate. We have a well-functioning outreach team with HOPICS.
- 5. Roderick Are we pressure washing sidewalks? Yes. CRDC and GAP can pressure wash.
- 6. Joy Can someone send us notification when washing has been done. Up until August 1, we had pressure washing once a week to be divided between 6 regions. After August 1, we will be able to pressure wash more often and we will send you the dates. Dates provided reflect when power washing is conducted in different areas within CD 8.
- 7. RaShon How do you track who has been offered help and who refused help? Records are tracked and maintained by the Outreach team. It takes 3 6 offers before a homeless person says yes or is forced to move. HOPICS along with LASA tracks this information. We meet with HOPICS weekly. LASA (joint effort between the county and the city) contracts HOPICS (non-profit organization to do outreach services).
- 8. Joy Cannabis Enforcement Hearings conducted by Administrative Lawyers LAPD, City Attorney, Council members. Task Force led by LAPD.

- 9. On Vermont what part of the homeless are in the in City of Los Angeles Most of the homeless on Vermont are in RVs in the Center medians. The Center medians are county property. The City and the County will work together to address the issue. County Supervisor will be included.
- 10. Introduction of Jasmine the newest member of the team. She will attend ECSWANDC meetings and the Block Club meetings.
