I. Call To Order

III. Administrative Motions (Discussion & Possible Action) (min)

- ShaRon Davis brought forth a motion to table the review and approval of the April 2022 minutes. RaShon Chavis seconded the motion. Motion unanimously passed.

V. **New Business** (Discussion and Possible Action)

- Metro Florence BSRT Project proposes to designate two lanes (both near the curb on either side of the street) to connect the Florence and Graham Metro Station with the Florence and West Blvd. Station. Parking will be limited along Florence Ave. between 7AM-10AM and 4PM-7PM. The Florence BSRT is projected to run every 8 minutes. The ECWANDC Board and meeting attendees expressed strong apprehension about the project. The issue was referred to the PLUM Committee who are asked to write a letter to Metro expressing the boards apprehension.
- President Lonella Enix appointed RaShon Chavis as the new alternate signer. ShaRon Davis brought forth a motion to approve the appointment. Timothy Henry seconded the motion. Motion passed unanimously.
- ARCO located at 2050 W. Manchester Ave. is again applying for a Conditional Use Permit to sell alcohol. The ECSWANDC Board will refer the matter to the PLUM Committee to decipher ways to obtain the stakeholders opinion on the matter and attend the hearing meeting(s) to express those opinions.
- The Board of Neighborhood Commissioners is continuing the restriction regarding inperson meetings, but the Department of Neighborhood Empowerment will no longer pay the annual licensing fee for Zoom. Neighborhood Councils are being asked to take on the \$200 annual licensing fee. ShaRon Davis brought forth a motion to approve taking

- on the cost of the \$200 annual Zoom licensing fee. Marcello Robinson seconded the motion. Motion passed unanimously.
- Community Input Statements RaShon Chavis brought forth a motion to table discussion and taking possible action on agenda items V. e. i., Council File #14-0366-S33 and agenda item V.e. ii., Council File #22-0280 to a future meeting due to lack of time. Marcello Robinson seconded the motion. Motion passed unanimously.

 - i. Jazz at St. Andrews Community Music Festival
 - 1. Sharon Davis brought forth a motion to increase the 2022 Jazz at Stl Andrews Community Music Festival in an amount not to exceed \$40,000 to cover the costs of printing posters and flyers, a videographer/photographer, beverages, food, the Southwest Village Plan survey, and additional AAA Rents costs as well as providing President Enix with the autonomy to approve what will be paid with the budget increase.

 - 1. Pre-Covid, the classes offered at Jesse Owens Pool were at no charge. Some classes have been discontinued and signing up for classes is mandatory. The charge for use of the pool is \$35 which limits the use of the pool for many community members. Does Jesse Owens Park have an advisory council? St. Andrews has issues with old, outdated, an unkempt equipment. The board should consider creating an Ad-Hoc Committee to address issues at both parks
